Booking and Payment Conditions - Accommodation at the CSN

Rooms at the CSN must be reserved before November 1, 2025.

- Upon receipt of the request, an invoice will be issued. Payment must be made no later than November 15, 2025.
- In the absence of payment by this date (November 15), the CSN reserves the right to cancel the reservation and not accommodate the concerned individuals.

Cancellation conditions:

- For any cancellation notified before November 15, 2025, 50% of the accommodation amount will remain due.
- For any cancellation notified before December 1, 2025, 100% of the accommodation amount will remain due.

Accommodation capacity - alternatives:

In case of saturation of our accommodation capacity, a list of nearby establishments will be provided to the participants, who will need to handle their own reservations, payments, and any possible transportation. No transfers will be provided by the CSN.

Individual information sheet:

Once the reservation is confirmed, each participant will receive an information sheet to fill out (contact details, dietary requirements, arrival and departure times, transportation needs, etc.). This sheet must be returned completed within the specified deadlines to ensure proper organization of the welcome.

Internal regulations and responsibilities:

Participants must sign and adhere to the internal regulations of the CSN, which outline the rules of conduct on the site as well as the financial and disciplinary consequences in case of damages, inappropriate behavior, or failure to comply with the instructions.

The organizer takes no responsibility if the rooms or belongings are damaged by the guests during their stay, and also accepts no responsibility for delays, cancellations, or costs incurred with the CSN.

9. TRANSPORT

NO official transfer for participants is required.

The organiser will provide transfers between Paris Airports and CSN only for Delegates accommodated in "Centre sportif de Normandie". Transportation fee is **80 EUR per person**. Transportation must be reserved to the Organization via email (<u>parajudo@ffjudo.com</u>) as son as possible and paid together with the competition fee.



10. VISA

The organizers will assist in obtaining entry visas for participants and officials if necessary, but the responsibility for obtaining the correct visa lies with each participant.

11. FUNDAMENTAL PRINCIPLES / PRINCIPE FONDAMENTAUX

All National Federations, clubs, officials, coaches and competitors participating in this event have to respect and accept the authority of the EJU officials, the rules and statutes of the International Judo Federation and European Judo Union. Individuals deemed to have acted against the EJU or IJF, their principles or purposes shall be subject to suspension or expulsion from the event.

11.1. RESPONSIBILITY OF CLUBS & NFS / RESPONSABILITE DES PARTICIPANTS

The athletes will participate under the full responsibility of their clubs & federations.

Clubs and National Federations are responsible for insuring their competitors against "injury and third part risk (public liability)" during the period of the event; each Club or National Federation must assume all responsibility for accident and health insurance as well as civil liabilities during the event for everyone under their charge.

The European Judo Union and the organizer of the event decline all responsibility.

The LOC of the event and the EJU have no liability for any claims of injury, illness or death arising from the travelling to and the participation in this event.

11.2. ATTITUDE OF COMPETITORS / ATTITUDE DES COMPETITEURS

The Clubs or Federations are responsible to the EJU concerning the general attitude of their competitors.

11.3. CONSENT FOR PHOTOGRAPHY/VIDEOS/FILMING

Delegates inscribed by their Clubs or National Federations for EJU events consent to the EJU and its media partners to use content of them, including data, live results, photographs and/or video recordings (hereafter referred to as Media). This media may be obtained from National Federations and EJU. It will also be acquired by the EJU and its media partners from in and around all EJU event venues. Media could be used in print and digital media formats including print publications, websites, e-marketing, posters banners, advertising, film, broadcast, social media, education purposes and other purposes. The National Federation and Clubs must ensure that they have the permission of each delegate or in the case of a minor the permission of the parent/guardian. If a delegate does not give consent, then the National Federation or Club must inform the European Judo Union by writing to headoffice@eju.net.

11.4. CONSENT FOR USE OF DATA AND DATA PROTECTION / CONSENTEMENT À L'UTILISATION DES DONNÉES ET PROTECTION DES DONNÉES

Delegates inscribed by their Club or National Federations for this event consent to the EJU processing their personal data with the application of GDPR principles by signing the Adapted Judo Disclaimer Form (AJDF). Clubs or National Federations must ensure that they have the permission of each delegate or in the case of a minor, the permission of the parent/guardian.
